Judgment is hereby entered in accordance with the terms of this Court's Final Approval Orders.


The Settlement Class is defined as: "All California citizens who made retail purchases of any Brookside branded Dark Chocolate Product labeled as containing 'No Artificial Flavors' in California on or after January 1, 2017 until March 30, 2022, for personal and household use and not for resale,

1 excluding Defendant and Defendant's officers, directors, employees, agents and affiliates, and the Court  
2 and its staff." (SA, § 1.1.)

3 Plaintiffs Suzanne Mirzoyan and Raymond Lee, on behalf of themselves and as representatives of  
4 the Settlement Class, shall take nothing from the complaint in this action except as set forth in the Final  
5 Approval Orders entered August 2, 2023. Pursuant to the Settlement Agreement, and section 664.6 of the  
6 California Code of Civil Procedure, this Court retains jurisdiction over Plaintiffs and Defendant to enforce  
7 the terms of the Settlement Agreement, Final Approval Orders, and this Judgment.
